Economic globalization has made national economies susceptible to unpredictable and rapid short-term capital inflows and outflows. This phenomenon, called Hot Money, is the major subject of the paper. The paper focuses on the development of a theoretical model pertinent to the phenomenon. Chapter 1 provides an overview of the topic and the motivation behind the investigation.
